The Camp Sunset Staff look forward to providing enrichment to your pet during their visit. We strive to provide a safe and secure environment for all of our guests, but realize that animals can sustain injuries during normal play.

This agreement is entered into by and between Camp Sunset Boarding and _____ (“Owner”) for _____ (“Pet’s Name” / Breed):

- By enrolling the above named and described pet, I represent that I am the legal owner of the named pet and I assume all risks, dangers and responsibility for injuries to the named pet. Therefore I understand and agree that I am solely responsible for any harm to my pet while he/she is boarding or in Day Camp.

- Boarding geriatric, chronically ill or otherwise debilitated pets requires extra care, which our caring and trained staff is happy to provide. However, special-needs pets, puppies and senior pets naturally have a higher risk of injury or stress-related illness, or exacerbation of any pre-existing condition. As such, by boarding your special-needs pet, puppy or senior pet with us you are waiving any claim for injury or illness experienced by your pet while in our care and that is not directly caused by negligence or lack of care on the part of our staff.

- I, the owner of above pet, understand and agree that during normal dog play, my pet may sustain injuries. All dog play is monitored by Camp Sunset staff to avoid injury, but scratches, punctures, torn ligaments, and other injuries may occur despite the best supervision.

- All dogs must pass a general assessment in order to attend Day Camp. No dog may be admitted that shows any signs of displaying inappropriate behavior that would cause harm to guests that have passed assessment. I, the owner of above pet, further understand and agree that in admitting my pet to Day Camp, I am representing that my pet has not harmed or shown any threatening behavior towards any person or other dogs. I understand that if I am enrolling my pet into traditional boarding (long-term or short-term, not Day Camp), I will inform the staff of Camp Sunset that my pet has displayed threatening behavior towards other dogs or people. So, the staff can take special precautions to protect the safety of my pet and the staff of Camp Sunset.

- Some dogs may become anxious or stressed and become threatening due to the change in their environment (other dogs barking, new people, enclosures, etc.), which may cause them to display inappropriate behavior. It is understood that any behavioral or physical health problems that develop with my pet while at Camp Sunset will be handled and treated as deemed best by the management of Camp Sunset, in their sole discretion, and I expressively agree to assume full responsibility for any and all expenses arising or relating thereto. I, the owner of the above pet, understand that the staff at Camp Sunset will make every effort to minimize the stress of my pet by doing the following:
 - Change the type of housing or room the pet is boarding in
 - Do a kennel transfer with upper – level staff
 - Obtain an exam from a veterinarian on staff
 - Ask the owner to pick up the pet if they continue to be stressed of the environment

- I, the owner of the above pet, further understand and agree that neither Camp Sunset nor any of its employees will be liable for any illness, injury, death and/ or escape of my pet provided that reasonable care and precautions are followed, and I hereby release all of them of any liability of any kind whatsoever arising from or as a result of my pet attending or participating at Camp Sunset.

- Furthermore, I understand that the "Assessment Questionnaire" has to be filled out completely and truthfully, so the staff of Camp Sunset can tailor a plan for boarding to ensure the safety of my pet and staff at Camp Sunset.

Initial: • I, the owner of above pet, understand and agree that my pet is healthy and will at all times, while attending Camp Sunset, have current vaccinations. Furthermore, I will not be enrolling my pet in Camp Sunset should they have any condition that could potentially jeopardize the health of other dogs or people and has not had potentially communicable condition within 30 days prior to enrollment. I also understand that even if my dog is vaccinated for Bordetella (Kennel Cough) there is a chance that my dog can still contract a strain of "Kennel Cough" that is not currently covered by the vaccine. I agree that I will **NOT** hold Camp Sunset responsible if my pet contracts Kennel Cough. The staff will contact the manufacturer of the vaccine to determine their warranty of the vaccine and testing to confirm the strain of "Kennel Cough" the pet has.

Initial: • I, the owner of the above pet, understand that my pet will need to be spayed/ neutered to enroll in Day Camp.

Initial: • I, the owner of the above pet, understands that Camp Sunset recommends bringing my pet's own diet, because my pet may develop gastrointestinal upset from diet changes. In addition, it is my responsibility to leave an adequate supply of food and medications for my pet during the entire time my pet is cared for by Camp Sunset. Should the food supply run out, I authorize Camp Sunset to use their in-house food to supplement the rest of my pet's stay at an additional cost. Should my pet run out of medication, I will make arrangements to have more medication delivered to Camp Sunset. Should my dog be observed for fleas or ticks while attending Camp Sunset, I authorize a treatment to be applied (at the discretion of a staff veterinarian) and charged to my account.

Initial: • I, the owner of the above pet, understand that Camp Sunset utilizes an outside fenced area to exercise guest and if my pet should escape, I will assume full liability.

Initial: • I, the owner of the above pet, understands that if I do not pick up my pet by 5pm of the agreed pick up date (listed on the "Check In" form), I will accrue additional charges. In addition, I agree that the staff at Camp Sunset may need to take whatever action they deem necessary for the continuing care of my pet and I agree and promise to pay Camp Sunset all costs associated with the special accommodations. Finally, I understand that if I do not pick up my pet as scheduled and make no contact with Camp Sunset, they are authorized to proceed with the Animal Abandonment Law (Sections 1834.5 and 1834.6 of the Civil Code) provisions.

Initial: • Camp Sunset reserves the right to refuse admittance to any pet or to dismiss any pet that does not meet the health, temperament or other Camp Sunset standards. The determination shall be made at the sole discretion by the management staff of Camp Sunset.

Initial: • I, the owner of the above pet, understand and expressly agree that each and every one of the provisions in this document shall be in force and effect and shall apply to each and every occasion on which I drop my pet off for day board or Day Camp, extended boarding as the case may be. This Agreement shall remain in full force and effect as between both parties until and unless otherwise cancelled or superseded by writing signed by both parties.

I, the owner of the above pet, hereby certifies that I have read and understand this Waiver and Release of Liability and the regulations set forth above. By signing this agreement, I agree to be bound by its terms and conditions.
